## Coal Lightering Service for Lakvijaya Power Plant, Sri Lanka from mid-September-2025 to mid-May 2027 (Season 2025-2026 and Season 2026-2027) - Bid No. LCC/24/LT/1 - R1

**The amendments to Tender LCC/24/LT/1, originally published on 30<sup>th</sup> August 2024.**

On behalf of Lanka Coal Company (Private) Limited (LCC), the Chairman of the Standing Cabinet Appointed Procurement Committee (SCAPC) of the Ministry of Energy (MOE), Sri Lanka, invited sealed bids for Coal Lightering Services for the Lakvijaya Power Plant in Puttalam, Sri Lanka, for the 2025/26 – 2026/27 period, from interested bidders.

Accordingly, several amendments have been made to the original bidding documents (LCC/24/LT/1) issued on **30<sup>th</sup> August 2024**. A revised bidding document will now be issued. Therefore, the previously issued original bidding document is hereby canceled, and bidders who have already purchased the original document will receive the revised version (LCC/24/LT/1-R1) free of charge.

Accordingly, the advertisement published on **30<sup>th</sup> August 2024** will be subject to following changes

1. The contract period will cover only **two coal unloading seasons: 2025/2026 and 2026/2027**.
2. The quantity should be **4.5 million MT, with a variation of +/-10%**.
3. The deadline for bid submission has been **extended to 10:00 AM (Sri Lanka Standard Time) on 06<sup>th</sup> March 2025**.
4. The **pre-bid meeting** is scheduled to conduct at **2.00 PM (Sri Lanka Standard Time) on 13<sup>th</sup> February 2025**, at Lanka Coal Office premises, both in-person and virtually. (Only those who have purchased the bidding document are eligible to participate).
5. A complete set of Bidding Document can be obtained for **LKR 100,000 (LKR One Hundred Thousand Only)** nonrefundable charge by interested applicants on submission of a written request with cash deposited receipt or Telegraphic Transfer (TT) receipt to LCC between **09.00 AM to 04.00 PM (Sri Lanka Standard Time)** till one day before the deadline of submission of bid, during working days from **Lanka Coal Company (Private) Limited, 51/3, Suranimala Place, Off-Dutugemunu Street, Kohuwala/Dehiwala, Sri Lanka 10350**.
