- Bidders shall comply with the provisions of Public Contracts Act No. 03 of 1987 and the regulations made thereunder. Under this Act any person who acts as an Agent, Sub Agent, Representative or Nominee for/or on behalf of bidder should register themselves under the Public Contracts Act No.03 of 1987 if the value of any tender they intend to take part exceeds Five Million Rupees (SLR 5.00 Mn.) and shall submit the relevant duly completed PCA Registration Certificate with the Bid.
- Each and every bid must be accompanied by a Bid Security in the amount of United States Dollars Fifty Thousand (USD 50,000.00) and must be addressed and delivered to Chairman CAPC, Ministry of Ports.
