Supply of 2.25 million MT +/- 10% of Coal under the Term Tender LCC/23/TT/1 for the Lakvijaya Coal Fired Power Plant at Norochcholai, Puttalam, Sri'Lanka for season 2023-2024

The annual coal requirement of Lakvijaya Power Plant (LVPP), Norochcholai, Sri lanka is procured through Term Tenders and Spot Tenders by inviting bids from registered suppliers. Ministry of Power and Energy INVITATION FOR BIDS - LCC/23/TT/1 FROM COAL SUPPLIERS ALREADY REGISTERED AND TO BE REGISTERED WITH LANKA COAL COMPANY (PVT) LTD SUPPLY of 2.25 Million MT ± 10% COAL FOR LAKVIJAYA POWER PLANT

The Chairman, Standing Cabinet Appointed Procurement Committee (SCAPC) of Ministry of Power and Energy on behalf of Lanka Coal Company (Pvt) Ltd (LCC) invites sealed bids to supply coal for the 900 MW Lakvijaya Power Plant, Sri Lanka, from already registered and to be registered coal suppliers.

Lanka Coal Company (Pvt) Ltd was incorporated in January 2008 for the procurement of the total quantity of coal for the coal fired power plants in the country.

The following should be duly noted by the already registered and to be registered suppliers.

- 1. 2.25 million MT ± 10% of coal is required to be supplied during the agreement period. Bids are invited from LCC already registered and to be registered suppliers to purchase coal on CFR Trimmed basis.
- 2. A complete set of bidding documents will be sent to the LCC already registered and to be registered suppliers with Lanka Coal Company (Pvt) Ltd via E-mail by LCC on 13 June 2023.
- 3. Suppliers who are in the process of registration or intend to do so, should complete the registration process at least one week prior to the closing date of 25th July, 2023.
- 4. Sealed bids accompanied by a Bid Security should be delivered to LCC. The address of LCC is given below. Bids will be received up to 1000 hrs on 25 July 2023 (Sri Lanka Standard Time) and will be opened immediately after. Bidders or their authorized representative may witness the opening of bids.
- 5. The Pre- Bid meeting will be held at 1400 hrs on 04th of July 2023 at LCC Premises.
