Procurement of Marine Diesel Engines and Gear Boxes with Associated Accessories for Sri Lanka Naval Ship Edithara II and Wickrama II

1. The Chairman, Ministry Procurement Committee (MPC) of the Ministry of Defence on behalf of the secretary, Ministry of Defence (MOD) now invites sealed Bids from eligible and qualified bidders for the following procurement.

Supply, Installation, Testing and Commissioning of Marine Diesel Engines and Gear Boxes with Associated Accessories for Sri Lanka Naval Ship Edithara II and Wickrama II.

2. Bidding process will be conducted through International Competitive Bidding (ICB).
3. Bids will be invited from Local Agents of **foreign manufacturer**, Importers and MOD registered suppliers and other reputed suppliers who possess at least **05 years experience** in supplying of Marine Diesel Engines and Gear Boxes with Associated Accessories and shall comply followings;
- Aforesaid Local Agent/ Supplier shall have at least 05 years Business Registration.
 - Bidder shall have successfully completed at least 03 similar nature contracts, during the **last 05 years** out of which, 01 contract shall consist with following scope and their contract sum shall not be less than **LKR 100 million** for each.
 - Vendor should have suitable workshop facility with technical staff including engineers of relevant field in order to attend warranty repairs in Sri Lanka to minimize down time.
 - Bidder shall provide minimum of 01 year Comprehensive warranty for entire system including all Engineering components of the Marine Diesel Engines Gear Boxes with Associated Accessories from the date of commissioning.
 - Bidder shall provide **10 years** after sales service/technical support and guarantee for availability of spare parts, software and accessories from manufacturer. (On completion of warranty period)
 - There shall be a local office or locally registered agent in Sri Lanka for the any query/ repair of the Marine Diesel Engines, Gear Boxes with Associated Accessories within the warranty period.
 - Vendor should provide OEM certificate for offered Marine Diesel Engines and Gear Boxes with Associated Accessories.
 - Availability of manufactures authorization for Local bidder and should provide certification.

4. Contract completion period is **180 calendar days** from the date of signed the contract.

5. Qualified bidders shall possess legal right for the above procurement and the Bidder should possess valid business registration under Public Contract No. 03 of 1987. A copy of the certificate for Business Firm Registration should be submitted with the bidding document. Additional details are provided in the Bidding Documents and few important extractions of the act is as follows.

"any person who act as an agent or sub-agent, representative or nominee on behalf of any bidder, shall register himself and such public contract in accordance with the section 10 and shall furnish to the register the particulars required to be furnish under section 6"

"where any person is an agent, sub-agent, representative or nominee for or on behalf of a bidder, he shall first produce a certificate of his appointment as agent sub-agent, representative or nominee to the registrar before he registers himself and the public contract under this section.

Bidders are advised to present the registration certificate before purchasing the bidding document, according to the "public contracts act no 3 of 1987", if relevant.

6. Eligible bidder should submit the Certification of International Standards on the compatibility of the production.

7. Financial Capability and other qualification requirement: Average annual turnover of the bidder shall not be less than Sri Lankan Rupees (LKR) **500,000,000/=** in last three years.

8. Interested eligible bidders may obtain further informations and inspect the Bidding Documents (Free of charge) at the address indicated at below para 15.

9. The bidder and their local agent should have not been blacklisted at any specific time.

10. A complete set of bidding document in english language may be purchased by interested bidders on the submission of a written application to the address indicated at below para 15 from **25th December 2023 to 04th February 2024 (0900 hrs to 1500 hrs)** upon a payment of a non-refundable fee of LKR 40,000.00 (Sri Lanka Rupee Forty Thousand) The method of payment will be cash.

11. Late bids and electronically submitted bids will be rejected. Bids will be opened immediately after closing of bids (**At 1100 hours on 05.02.2024**) in the presence of the bidders' representatives who wish to attend.

12. The bid should be valid for **91 days** from the date of bid opening.

13. All bids must be accompanied by "**Bid-Security**", of **Sri Lankan Rupees 6.0 Million (LKR 6,000,000.00)**. The bid security (ITB 20.2) shall be a Bank Guarantee issued by a commercial bank operating in Sri Lanka, approved by the Central bank of Sri Lanka. The bid security shall be **valid 119 days** from the date of closing of bids and should be submit as per the format given in bidding document.

14. Pre bid meeting will be held at Navy Headquarters, Colombo 01 on **08th January 2024 at 1000 hours**.

15. Bid must be delivered to the following address on or before **05th February 2024 at 1100 hrs**.
