Eligibility for Application - Conditions regarding the Purchasing of Air Passage

1. The business should be registered in Sri Lanka. (Copy of the Registration Document should be

forwarded with the application.)

2. Since the quotation will be considered on the basis of the supply category under which the

institution is registered, the category under which the institution should be registered must

be stated clearly.

3. The Application form for the above mentioned registration can be downloaded from our

ministry's website (www.mfa.gov.lk). Incomplete applications will be rejected.

4. Applications made for registration will be scrutinized and the applicants will be registered as

ministry suppliers after the eligibility has been proven.

5. Strict legal action will be taken against those applicants who produce false documents for

registration and get registered as suppliers.

6. The Secretary to the Ministry of Foreign Affairs reserves the right to call for quotations from

one registered supplier, several registered suppliers, all registered suppliers who are

registered under a certain item or a supplier not in the registered list.

7. If the Secretary to the Ministry of Foreign Affairs finds that the supplies of a certain supplier

are not satisfactory or irregular or the supplier has acted fraudulently, the Secretary has the

authority to black list that supplier and to delete the suppliers name from the register.

8. With regard to the registration of suppliers and the procurement of supplies from registered

suppliers, is subjected to the laws, regulations and instructions that have been issued so far

and may be issued in the future by the government of Sri Lanka and the Ministry reserves the

right to make alterations in the conditions and procedures relating to the list of suppliers and

their supplies.

9. Supplies should be effected within the specified days mentioned in the quotation calling from

the date of placing the order and the additional expenses incurred should be borne by the

supplier.

10. All the Service Providers should be registered under Civil Aviation Authority of Sri Lanka
