Bidders or their authorized representatives are requested to present at the opening of bids.
- 03. All blanks in the Form of Bid and the Quotation should be duly filled and signed by a person duly authorized to sign on behalf of the vendor. Power of attorney should be submitted along with the bids whenever relevant.
- 04. The bidder should write the total bid price (exclusive of VAT) in the Form of Bid in figures as well as in words. Where the amount given in figures differs from the amount given in words the **amount stated in words** will be accepted as the correct bid price.
- O5. The bid must be placed in a sealed envelope and marked as "Service of Motor Insurance Cover-2025" at the top left hand corner of the envelop and addressed to the "Director General (Administration), General Administration Division, Ministry of Foreign Affairs, Foreign Employment and Tourism, 9th Floor, Ceylinco House, 69, Janathipathi Mawatha Colombo 01". - 05. Insurance company is expected to provide coverage for vehicle accident occurred any place in the country which need to be covered all 25 districts including carrying charges.
- 06. Alternative bids are not allowed and only one quotation from one insurance company is conceded for Technical Evaluation activities.
- 07. Sample copy of the insurance policy which is to be issued by the bidders should be attached to the bid documents.
- 08. The response time in the event of an accident should be immediately from the time of informing by the client or his / her representative.
- 09. It is required to have 100% damages recovery in case of an accident. In a situation where it is less than 100%, there should be a prior agreement with the client.
- 10. 50% of the total repair estimate has to be settled immediately after the preparation of the estimate upon request by the client and the final bill has to be settled without any delay, and all the payments shall be made with the consent / approval of the Ministry.
